NOTICE OF BREACH AND DEMAND FOR REDRESS

*Issued under Natural Law, the Declaration of Independence,
and the Constitution as Instrument of Their Securing*

NOTICE IS HEREBY SERVED UPON:

Standing

My rights are not granted by any government. They are unalienable, pre-existing, and self-evident. The Declaration of Independence states the foundation: governments are *instituted among Men to secure these Rights* — and derive their just powers from the consent of the governed. The Constitution is the instrument by which a specific government was constituted to that end. It is not the source of the rights. It is the contract for their securing.

When that contract is breached — when the institutions sworn to secure life, liberty, and the pursuit of happiness instead destroy them, withhold records of them, or pursue the disabled while shielding the powerful — the contract is voided as to the breaching parties until redress is made. This is not a request.

This is *notice of breach*, served by a living, unalienable claimant, in the exercise of rights that no statute can extinguish.

Demand

The government exists to secure unalienable rights and promote the general welfare. When it instead causes harm, withholds records, and pursues the vulnerable while shielding the powerful, the contract is voided until redress is made. The breached party owes no further performance to the breaching party until cure.

I am not asking. I am noticing. I am demanding. The system will honor the obligations it claims to uphold, or it will stand on the record as having refused.
